

**CMP – Annual Renewal Form**  
**May 1 – April 30**

For a CMP to maintain an “active” status within the Association, they must complete activities which have CMP Continuing Participation points between May 1 and April 30... To complete this obligation, the CMP shall participate in activities and/or attend sanctioned events that offer Continuing Participation points during the period. The CMP maintains completion certificates for each activity or event and upon their renewal provides the certificates as evidence of completion of their Continuing Participation obligation. The CMP must complete a total of 3 Continuing Participation points during the one-year period stated above and pay annual renewal dues. [Renewal dues are \\$75.00 per year, see Preferred Corporate Partner benefit next page.](#)

- 1) Non-renewal “Inactive” status”, if I’m a CMP and don’t do these things am I still a CMP? yes, you are still a CMP – not an active CMP and you cannot benefit directly through any of the marketing, instructing, etc. the Association is doing for active CMP’s.
- 2) “Inactive” is not eligible until they become active again.

**[How does a CMP Receive their CMP Continuing Participation Certificates?](#)**

- Certificate of “Continuing Participation” – Events & Classes- The Association will issue Certificates of “Continuing Participation” at all eligible events.
- Certificate of “Continuing Participation” – Committees, MBBA Board Member, MBBA Officers
- Certificate of “Continuing Participation” – Teacher and/or Speaker
- Certificate of “Continuing Participation” – Housing Related Community Event

**Eligible Activities:** The following list of activities will satisfy “Continuing Participation” credits:  
*Any combination of completed activities can complete a CMP’s “Continuing Participation” except that no more than one Housing Related Community Event can be used in any year...*

**Speaking at an MBBA-NH sponsored function/conference – 3 credits**

**MBBA – Board Member –2 credits**

**Attending the Tri-State Mortgage Conference – 2 credits**

**Attending the Principles of Mortgage Banking II (POMBII) Module – 1 credit/module**

**Attending the MBBA-NH Compliance Conference – 2 credits**

**Attending MBBA-NH Mini-Events – 1 credit/event**

**Participation on Social Media Outreach Committee – 1 credit**

**Participate in Housing Related Community Event – 1 credit/event**
